Financial Report

The Maryknoll Technical Secondary School Former Students' Association (MTSSFSA) commenced its operations in September, 1995. At that time only ten members registered and paid their fees. However, as of October 31, 1996, there were 1,000 former students returned their registration forms and 248 of them had paid their membership fees to become official members. One may comment that the result is yet not satisfactory, but to a certain extent it is pretty encouraging.



Being the Treasurer of MTSSFSA, it is my job to provide you a clear picture enabling you to understand how MTSSFSA is functioning from a financial perspective. It is also my intention from now on to convey some financial messages to you on a regular basis so as to keep you updated with all the information regarding our sources and application of funds. Please, therefore, make sure you will get every single issue of our periodicals and look for my "Financial Report" for more. You may find something surprising!

To start with, let me present you a self-explanatory Income Statement of MTSSFSA for the balance closing on September 3, 1996. This statement has been verified by "W.H. Wong & Co." (a certified public accounting firm founded by one of our former students (1972), Mr Wong Wing Hon) for your review:

Goals & Objectives:

- To computerise the membership proprietary personal data and act as the governing body to protect their information in joint efforts with school.
- 4. To provide latest membership listing.
 - a. For the purpose of mailing approved newsletter to all memberships.
 - For the promotion of non-active member to become active members of this subcommittee.
 - For the purpose of maintaining membership contact, this subcommittee would perform according to good ethics and Hong Kong regulation.
- To hold subcommittee meeting at least once per quarter.
- 6. To make presentation and introduce former student membership services to new graduates.
- To increase the active membership by 25% in each class with the help of class representative.
- To nominate subcommittee memberships with representation from all classes.
- To maintain membership classification system of active member.
- 10. To maintain contact and networking with all members with minimum annual information update.

Definition:

All former students who have graduated form Maryknoll Technical School (MPS) are automatically members of the Association. Anyone who has enrolled in a regular course at MPS can become a member upon request.

Active members (those contributing at least the minimum gift, as established by the Board of Directors, to the Annual Fund) receive all publications; appropriate mailings for MPS Former Student meetings, reunions, programs and activities; and have full voting rights and all other privileges of membership. Only active members are eligible for election to the Association council and only active members can be represented on the Council.
